Consequent to reintroduction of reimbursement/credit card facility to the employees/pensioners and their dependents and family pensioners with effect from 01.04.2009 with a life time ceiling amount of Rs.2.0 lakhs for inpatient treatment at CGHS, NIMS & SVIMS rates formulated vide T.O.O.Ms.No.301 dated 31.3.2009.

2. As per para 3(xi) it was stipulated that “*a declaration of dependency shall be submitted by employees be recorded by Head of Departments for availing medical facility and thereby every year in the first week of January*”.

3. The medical policy in Government is under active process for implementation.

4. Hence all the Heads of Departments of APTRANSCO are requested to call for declaration of dependency with all details from the Employees/ Pensioners and Family Pensioners as per “Annexure enclosed” by **30th March’ 2013** positively for implementation of New Medical Scheme as and when Government issues order on New Medical Policy.
