In the reference 4th & 6th cited, orders were issued enhancing the ceiling limit from Rs.4,500/- p.m to Rs.9,000/- p.m or 50% of the expenditure incurred towards purchase of medicines/injections/ investigations, whichever is less, to the employees / pensioners /their dependents /family pensioners who have undergone kidney transplantation and dialysis, without linking with the regular ceiling limit.

2. Representation has been received requesting to enhance the above said ceiling amount from Rs.9,000/- p.m to Rs.14,000/- p.m as the cost of medicines /injections/investigations are increased.

3. After careful consideration, TS TRANSCO hereby issues orders enhancing the ceiling limit from Rs.9,000/- p.m to Rs.14,000/- p.m or actual expenditure whichever is less, incurred towards purchase of medicines/ injections/ investigations for the benefit of employees / pensioners /their dependents /family pensioners who have undergone kidney transplantation and dialysis. This facility shall not be linked with the regular ceiling limit.

4. This order shall come into force for the treatment taken on or after the date of issue of the order.

5. The other terms and conditions mentioned in the T.O.Os 4th & 6th cited holds good.

6. This order is issued with the concurrence of Joint Managing Director (Finance, Comml. & HRD) vide Regd. No.411, dt. 7-2-2017.
